


CURBSIDE COLLECTION REMINDERS

CART PLACEMENT IS IMPORTANT!

Remember to place your carts at least 3 feet apart and 3 feet away from any obstacles (trees, cars, mailboxes, etc.) to allow the automatic arm to lift and empty the cart.



 Have your items curbside **no later than 6 a.m.** on your scheduled service day.

HOLIDAY SCHEDULE

There will be no collection on **New Year's Day, Fourth of July, Labor Day, Thanksgiving, and Christmas.** Collection service will be delayed by one day for the remainder of the week. Please visit www.WMFloridaHoliday.com for more information.

HURRICANE SEASON

CART OPTIONS

If you're not satisfied with your Trash or Recycling cart size, starting **January 2, 2026**, you may request a different size by calling WM at **772-569-1776**.

Residents may purchase an additional Trash cart or Yard Waste cart from WM for a one-time fee of \$100, which covers the cost of the cart and delivery. There is an additional \$10 monthly charge per extra cart, billed annually at \$120 per cart. These fees must be paid directly to WM by the resident. The maximum number of combined Trash and Yard Waste carts allowed is (4) per residential unit.

Residents may request an additional Recycling cart at no cost for the cart and delivery, and with no additional monthly fee.

Frequently Asked Questions

I currently do not have curbside collection service, why am I receiving a cart for collection service?

Beginning **October 1, 2025**, unincorporated Indian River County will transition to Universal Curbside Collection Service for all unincorporated Indian River County residences.

Each residential unit will receive once per week collection service for carted **Trash, Recycling, Yard Waste, and up to (4) Bulk Trash** items.

Universal Curbside Collection Service means the cost for these services are included in your annual non-ad valorem assessment, which is part of your property tax bill.

What if I have two Trash carts?

- The old trash carts must be picked up prior to **October 1, 2025**.
- If you purchased a second trash cart in 2025, you would receive a second cart at no additional cost for the cart and delivery.
- If you purchased a second trash cart before 2025, WM will contact you with an option to purchase a new additional cart for a one-time fee of \$100 per cart.
- Beginning **October 1, 2025**, the resident will be responsible for paying WM an additional \$10 monthly charge per extra cart, billed annually at \$120 per cart.

WM is pleased to be the environmental services provider for unincorporated Indian River County. Beginning **October 1, 2025**, the county will transition to Universal Curbside Collection Service, making it easier and more convenient for everyone to manage their waste and recycling.

Each residence will receive once per week collection service for carted **Trash, Recycling, and Yard Waste, and up to (4) Bulk Trash** items. Please see the enclosed map for your **NEW** service day for all services.

Universal Curbside Collection Service means the cost for these services are included in your annual non-ad valorem assessment, which is part of your property tax bill.

CURBSIDE COLLECTION SERVICES



TRASH

- All bagged materials must fit inside your Trash cart with the lid fully closed. Refer to **Bulk Trash** for removal of large items.
- Please refer to the map for your **Trash** collection day.

BULK TRASH

- WM will collect **up to (4) Bulk Trash** items each week per residential unit.
- Acceptable items include furniture, white goods (appliances such as a stove, washer, dryer, fridge, etc.), grills, lawn equipment, furnaces, bicycles, and vehicle tires up to 25 inches in diameter (on or off the rim). Please note carpet and rugs are excluded from curbside collection.
- Please refer to the map for your **Bulk Trash** collection day.



RECYCLING

- Clean paper and flattened cardboard; metal cans; glass bottles and jars; plastic bottles, jugs, and tubs (lids on).
- Please **DO NOT** bag recyclables, items must be loose inside your recycling cart.
- For more recycling information, please download the **CARter's Corner App**.
- Please refer to the map for your **Recycling** collection day.



YARD WASTE

- Yard Waste such as small branches, grass clippings and trimmings must be placed inside your cart. No small piles on the ground, please. The lid **DOES NOT** need to be closed.
- Resident-owned containers will not be serviced.
- Please refer to the map for your **Yard Waste** collection day.

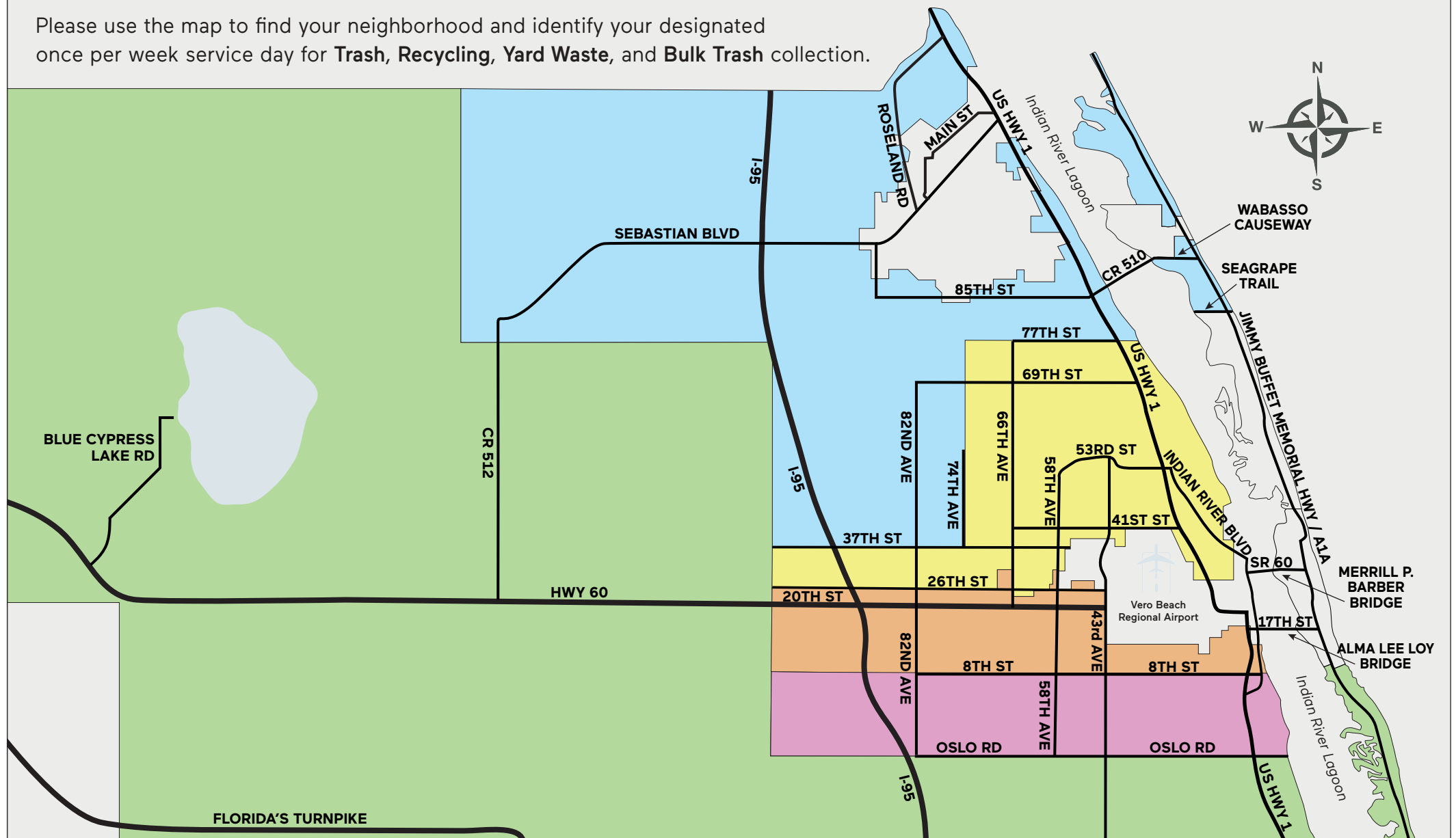
BULK YARD WASTE

Items too large to fit inside your Yard Waste cart will not be collected on your scheduled carted Yard Waste collection day. It is the responsibility of the resident or property owner to remove Bulk Yard Waste piles that cannot be placed inside the cart.

Several options for removal are:

1. Self-haul to the Indian River County Landfill
2. Self-haul to any of the five Indian River County Customer Convenience Centers if the items are less than 3 inches in diameter.
3. Hire a private contractor.
4. Contact WM at 772-569-1776 to schedule a collection for \$25 per cubic yard.
